1. Introduction & Background

The program also works to improve the person's cognitive skills. Once his/her time is completed, the opportunity is given to get the practical support for the journey into a new life. Whatever the reason the person was placed in the program, they succeeded. We step in when they are ready to graduate. We try to facilitate the next steps to help them be successful. We want to help them plan for a new start, so they don't return to that center or any another.

A God Send, Inc., is in need of a Life Coach and is accepting proposals in response to this “RFP,” in order to find a qualified source to provide a Life Coach. Our goal with a Life Coach is to:

1. Provide an assessment of Candidate
2. Assist with job applications
3. Provide 3 sessions of job interview training
4. Help the Candidate develop a life plan
5. Make recommendations for counseling as needed.

2. Submission Guidelines & Requirements

The following submission guidelines & requirements apply to this Request for Proposal:

1. First and foremost, only qualified individuals or firms with prior experience on projects such as this should submit proposals in response to this Request for Proposal.

7. If you have a standard set of terms and conditions, please submit them with your proposal. All terms and conditions will be subject to negotiation.
